2.0 Standing Items:

2.1 President's Report:

- -U13 HEO appeal on behalf of Chris Peasley (11 2E, 11 2F suspension). Appealed based on first eyewitness accounts. Hearing results, suspension reduced to 4 games. Association is offering to pay for the appeal fee.
- -U16 racial slur incident investigating situation. Coach suspension handed out.
- D4: Discriminatory slurs to stop (5 game suspension and a written essay consequence)
- -Amalgamation to be a long-term study.
- -District \$650 fee on its way.

League: Penalty minutes to be kept down

- -Boundaries: last looked at in 2019
